Resolution No. 23/23

of the KDPW_CCP S.A. Management Board

dated 28 November 2023

§ 1

Pursuant to § 7 (1) and (2) of the Rules of Transaction Clearing (non-organised trading), the Management Board of KDPW_CCP S.A. resolves:

1/ to set out, in the annex to this Resolution:

a/ an additional day in 2024 which shall be excluded in the OTC clearing system in the calculation of the dates set out in the KDPW_CCP S.A. regulations with regard to the clearing of transactions concluded in a given currency in non-organised trading and with regard to the adjustment and payment (intraday) in a given currency of contributions to the OTC guarantee fund referred to in § 1(8) of the Rules of Transaction Clearing (non-organised trading) and of margins (transactions in a given currency shall not be cleared on this day; hereinafter in the appendix to this Resolution: "Additional day without clearing and adjustment of payments in the system"),

and

- b/ additional days in 2024 which shall be included in the OTC clearing system in the calculation of the dates set out in the KDPW_CCP S.A. regulations with regard to the clearing of transactions concluded in a given currency in non-organised trading and with regard to the adjustment and payment (intraday) in a given currency of contributions to the OTC guarantee fund referred to in § 1(8) of the Rules of Transaction Clearing (non-organised trading) and of margins (transactions in a given shall be cleared on these days; each of these days hereinafter in the appendix to this Resolution: "Additional day with clearing of transactions and adjustment of payments in the system");
- 2/ to approve a schedule of additional days on which transactions concluded in a given currency in non-organised trading shall not be cleared/shall be cleared (excluding Saturdays and Sundays), in the wording set out in the appendix to this Resolution.

§ 2 This Resolution shall come into force on the day of its adoption.
